- \$20.00 application fee for every primary tenant application money order or cashier's check ONLY (no cash)

applicant will be contacted by Atlantic Blue Coast Realty to schedule an appointment to view requested home(s) – appointment(s) to view properties <u>may not</u> occur on same day as application submission.

*** NO EXCEPTIONS ***

What is needed after you find a property that you like?

the following items will be required to process applicant's approval:

- items listed above to view properties
- proofs of all stated incomes listed on application(s)
 - o current pay stubs no more than 30 days old
 - o official letters from county confirming SSI, child support, HUD, etc
 - o official letters from attorney confirming worker's compensation
 - o in *some* cases, contracts for employment from certain businesses may be acceptable
- list of ALL addresses applicant has occupied in the previous 5 years
 - application has space for 3 most recent addresses, use separate paper for any additional
 - full addresses must be provided just a town or street name may not be acceptable
- recent utility bill addressed to current residence no more than 30 days old
- accurate landlord contact information for any/all addresses in previous 3 years
 - failure to provide this information may result in denial of application

What do you need to know about the approval process?

- based on information collected from application or references, in addition to the standard Security Deposit, approval may require a fully refundable Court Fee Deposit
 - \$126 for the 1st primary Tenant/signer... \$30 for each additional Tenant/signer
 - to be due at Lease signing
- rent payments cannot exceed 40% of the confirmed income
- applicant must have AT LEAST six (6) months at current job to be considered
 - o applicants with less than nine (9) months at current job may be subject to additional Court Fee Deposit
- notice of application denial will be sent via email only... application fees will NOT be refunded for denials
